# **FUNDING RECREATIONAL SPACES** IN BLACKFORD COUNTY

Saturday, August 15, marked the ribbon cutting and grand opening of the Wilderness Park Prairie Restoration project. Wilderness Park is part of the Hartford City Parks Department's system of parks and located on the south side of Hartford City between the Little League ball diamonds on its west and the Amvets Post on the east. The prairie has been established on the eastern five acres.

In the past three years, the Foundation has provided two grants totaling \$28,400 for Wilderness Park. The first one funded expanded parking and signage. The second grant provided a gathering space designed by Ball State architecture students to be used for environmental education and observation. The center connects the prairie to the previously existing nature trails.

The Foundation has supported several public parks projects over the last few years through its grants program. In addition to this Wilderness Park Prairie Restoration project, grants have been awarded to help construct the Blackford Greenway to Blackford High School; to build the nature play area east of the Hartford City Public Library; and to erect the amphitheater at the northeast corner of the Courthouse square.

All of these greenspace projects tie to the wishes expressed in community surveys and with the Focus Forward community development plan that more active recreational opportunities be available, especially for families.

# Community Grants Awarded

Eleven grants were given to community organizations in the first round of grants from the Foundation for 2020. They totaled \$69,739.

Arts Place, Inc. received two grants (\$24,350) for its local MusicWorks program and its Arts in the Parks summer program. Montpelier Civic Center was awarded \$3,732 for restroom upgrades. Grace United Methodist Church was granted \$3,000 for a summer food program for children. The Blackford County 4-H Council was given \$2,500 to purchase 4-H manuals for members. Blackford County Schools received \$9,929 for an Early Childhood Education Coalition. Blackford Development Corporation was granted \$10,000 for plans for the Weiler lot northeast of the Courthouse. The Blackford Youth Soccer League received \$10,728 for improvements to the soccer complex. Blackford County Imagination Library received \$5,000 to continue the preschool monthly mailed book program through Dolly Parton's Imagination Library.

The next round of grants will be awarded in September.
