

OUR FUNDS SUPPORT

In addition to competitive grant awards, the Foundation also distributes funds to nonprofits that either set up funds for ongoing support or that had donors wishing to support the specific organization. Thirty-one nonprofits received \$225,930 through these distributions in 2020. Almost two-thirds of this funding went to community development nonprofits and government groups that are improving parks, cemeteries, and building facilities.







OUR SCHOLARSHIPS HELP

Nearly 50 local families and civic organizations have established scholarships for students to attend college and vocational schools. Many of these honor the memories of respected family members and community leaders.

In 2020, 67 scholarships went to 39 local graduating high school seniors for over \$64,200. Another \$8,890 was awarded to students already studying at a college or vocational school.


